



2018 KENTUCKY TRUCKING ASSOCIATION SAFETY DIRECTOR OF THE YEAR

Each year, the Kentucky Trucking Association Risk and Safety Management Council recognizes an active member of the Council who has excelled in the field of truck safety. Nominees must be employed by a member company of KTA and performing duties directly related to fleet safety and loss prevention. The Safety Director of the Year Award is designed to promote and advance high standards in qualification and performance of individuals employed in safety field. The award will be presented at the Kentucky Trucking Association Annual Convention in September.

THE ELIGIBILITY REQUIREMENTS ARE AS FOLLOWS:

1. This award will be presented to the individual who has excelled in the field of fleet and commercial motor vehicle safety.
2. Unsuccessful nominations in any given year may be re-submitted in the following year. Award winners may not be nominated for the award again.
3. Nominees must be an active member of the Kentucky Trucking Association for the previous year and be in the employ of a Kentucky Trucking Association member company, directing safety activities of a truck fleet and responsible for the on-going development, implementation and management of the safety program in the fleet.
4. Nominations must be made by the employer.
5. As a condition of nomination, the nominee and his/her employer may be required to produce records verifying the qualifications of the nominee. All records and documentation will be held in strict confidence.
6. Kentucky Trucking Association will appoint an outside team of Judges to make the selection for this award.
7. Judging will be based on the professional qualifications and performance of the nominee, their success in advancing highway and industrial safety of the fleet under their control, the relationship and cooperation with governmental authorities which regulate operations of the fleet, methods employed solving safety problems and the individual's leadership and support of the Kentucky Trucking Association Risk and Safety Management Council and other professional safety organizations.
